

**ADVERTISEMENT FOR BIDS
REDI FORCE MAIN EXTENSION TO FAIRGROUNDS
SJRWMD CONTRACT NO. 38024
TOWN OF CALLAHAN, FLORIDA**

Sealed Bids for the construction of the REDI Force Main Extension to Fairgrounds project will be received by the Town of Callahan, Florida at the office of the Town Manager/Public Works Director, 542300 US Hwy 1 (P.O. Box 5016), Callahan, Florida 32011, until June 5, 2023 at 2:00 p.m. local time. At that time, the Bids received will be publicly opened and read aloud.

The Project includes the following Work: Furnishing all labor, equipment, and materials necessary to install a concrete duplex submersible wastewater pump station; approximately 300 LF of 4" PVC/FPVC force main (conventional excavation/directional drill); approximately 5,300 LF of 8" PVC/FPVC force main; connection to an existing force main; approximately 1,060 LF of 8" PVC/FPVC water main; connection to an existing water main; installation of fire hydrants; installation of all associated valves, fittings, and appurtenances; site work; electrical work; and associated restoration. The project includes furnishing and installing a stationary standby emergency diesel-generator at the pump station site as an Additive Alternate. Project funding will be from a combination of St. Johns River Water Management District REDI Cost-Share funds for the wastewater pump station and force main work and Town of Callahan funds for the water main work.

Bids are requested for the following Contract: REDI Force Main Extension to Fairgrounds, SJRWMD Contract No. 38024.

Prospective Bidders may examine the Bidding Documents at the Issuing Office, Monday through Friday (excluding holidays), and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Bidding Documents will be provided electronically as portable document format (PDF) files and as printed Bidding Documents, both for a non-refundable charge of \$200 per set payable to "Mittauer & Associates, Inc." Upon Issuing Office's receipt of payment, the digital files will be emailed, and the printed Bidding Documents will be sent via UPS Ground. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including addenda, if any, obtained from sources other than the Issuing Office.

Bid security must be furnished in accordance with the Instructions to Bidders.

To be considered qualified, Bidder must be licensed to engage in the business of contracting in the State of Florida by the Construction Industry Licensing Board and must have successfully completed, as prime contractor, a minimum of 3 projects of a similar nature involving force main/water main installation within the past 5 years, each having a minimum contract value of \$400,000.
