- Mayor Thank you to everyone who worked on the Parade Float it was beautiful and thank you to everyone who participated for the Movie in the Park. I enjoyed playing Santa for a few hours. I did get an update on the grants from Mike Williams the DEO grants for the water and wastewater. The Town has been receiving some large invoices that are generally due in 30 days, so we had to pay out some large sums. Its coming faster than we can get the pay requests for reimbursement back. Mike Williams and Shawna Gugliuzza have been exploring opening a line of credit with one of the banks Ameris Bank or First Federal Bank so that we do not draw down funds to a level we are uncomfortable with. We may not have to go down that route what triggered this was a \$972,000.00 invoice. If we do move forward both banks are quoting about a 5% interest rate and an administrative fee. I just wanted the council to be aware of everything. Also starting in January, I will start taking some time with each council member to discuss the different departments and see if there is anything I can help with.
- Mrs. Bishop Vargas- On last Tuesday we had a Nassau County Safety Team Meeting and there was a request put a sign in on US 1 and Old Dixie HWY for a No U-Turn they did a field review and recommended against putting the sign up. It is now closed. December is Drunk Driving Prevention Month. Mrs. Bishop-Vargas passed out pamphlets that had recipes for non-alcoholic beverages.
- Mrs. Fleming This past Thursday we had a meeting with the Nassau County Economic Development Board and different entities were invited. The meeting was held in the Fire Station. The meeting was to give everyone in the County a chance to get together on the updates and growth that we have had in the county. Mrs. Fleming was able to present at the meeting. It was a good place for the local small businesses to have a voice. It was a great opportunity to network and develop connections. The parade was great and thank you for everyone who worked on making it happen.
