To replace the five failing windows with custom-made historically identical windows is estimated at \$12,500.00, The fire alarm system will be an estimated cost of \$7,200.00, and to replace the HVAC system is an estimated cost of \$19,500.00 with an estimated cost totaling \$39,200.00
