- Northeast Florida Community In Action Agency Pastor Clowers & Maxine Simmons
 - Informed the Council about a Community Wide Project to provide the area children fully stocked backpacks for the upcoming school year.
 - \circ The Event will be Saturday the 23rd from 10 AM 3 PM.
 - Stated area organizations, businesses, and churches have donated to this event and ask the Town to consider helping with some of the \$700 shortage.
 - With Mayor Rau out it was left to Mr. Bass to make the decision, and due to the time constraints, Mr. Bass decided to give the full \$700. The Council Consensus was unanimous to do the full \$700.
- Nassau County Economic Development Board -- Laura Dibella
 - 8 projects on the Pipeline for the Westside of the County right now.
 - Project MOM is still a very strong contender, and would provide approximately 1750 jobs to the area.
 - Thanked the Council for having Randy Knagge sit on the Board to represent the Town's interest.
 - Asked the Council to consider supporting the NCEDB.
