- Water & Sewer Adjustments
  - Mr. William Hazlett 45120 Oak Trail Mr. Fontes stated that in July Mr. Hazlett's usage was 3,000 gallons higher than normal. Resident stated he was gone for 3 weeks of that month. It is thought that theft has occurred. The sewer overage was \$26.95.

    - Discussion: Mayor Rau stated this doesn't meet the requirements set in our code for an adjustment. If this is allowed it will set a precedence for others to think they should have an adjustment to their bill, as well.
