Town Council Meeting Minutes

January 20, 2015

- Stated that the Council should consider waving Annexing Fees to attract willing Participants to annex into the Town.
- Also, stated that we should look into how much it would cost the Town to tie into the gas line that runs through it. That way we could possibly attract more residents & businesses by being able to offer Natural Gas to them.


➤ **Mr. Fontes**

- Stated that he enjoyed the article in the Paper with everyone's wishes for the New Year. He stated that he liked where the Mayor stated that his wish was for the Town & the County to work better together.
- He stated that, with that in mind, he would like to recommend that the Town of Callahan, The Town of Hilliard, and the County consider working together to build the Park that has been on hold at the old Mizell Tract of land that the County purchased years back. The Mizell Tract is located between Hilliard & Callahan. He stated that Lisa, Clerk for the Town of Hilliard, is amazing at finding Grants, and if we all are working together it is not a competition for those funds it is all of us working to help all of the people of the Westside of the County. He also stated that our side of the County needs more space for recreation like more ball fields, a Skate Park, and maybe even a pool.

 - Stated that it appeared that someone might be living in Mr. Rodney's house on Page Street that is supposed to be torn down.
 - Mr. Williams stated that he has purchased the permit to tear it down and has a year to complete it, so there is nothing we can do at this time.

- **Mrs. Knagge**
 - Thanked the Council for allowing her to help host the International Institute of Municipal Clerk's Conference this past week. Everyone loved the Cupcake tower & Chocolate Fountain and they all now know where The Town of Callahan is!
- **Mr. Williams** -- Nothing
- **Mr. Bass**
 - Stated he has been talking with people around town and the Consensus is they would like to see a Taco Bell and/or a Golden Corral come here.
 - Stated that the Fire Contract with the County has been signed and approved, but our Fire Fighters are still not being toned out.
 - Stated that he would like to invite Fire Fighters from the other stations that have closed down to come join our crew.
 - Stated that he has been approached about joining with the School Board and putting a pool in at the Middle School. The swim team from West Nassau has to go all the way to Fernandina to practice. Mr. Fontes stated that will all of the School Board regulations by the State and federally he doesn't think the regular citizens would be able to benefit from this.
 - Stated that he feels we really need to get serious about Annexing to make the Town Limits bigger especially since Crawford Diamond is growing and the growth potential out here is huge from those businesses coming. Mrs. Smith asked what we had to offer them to willing annex in. Mr. Bass stated that we have city water, sewer, and garbage to name a few things. Mr. Fontes said maybe we should consider waving the \$500 annex fee and more people would be willing.
