- Resolution 2015-R27 – Girl Scouts
 - Read by Title by Mr. Branham.
 - Discussion: Mr. Fontes stated in an effort to cut back spending he felt the girl scouts should get \$250 unless we stop the Wounded Warriors donation. Mrs. Smith stated she would rather keep it local with the Girl Scouts.
 - Motion to approve Resolution 2015-R24 for \$500 by Mrs. Smith and 2nd by Mrs. Shaw.

- Mr. Fontes asked Laura Diabella from the Nassau County Economic Development Board to speak.
 - Ms. Diabella stated the Town’s Support was greatly needed and appreciated. She asked the Town to continue you their support in this new Fiscal year.

➤ Mayor

- Received thank you note from the NCEDB for the Town's Donation.
- Showed the Council a PIN of the Town Seal to have as handouts. Council Consensus was they were nice & it would be a good idea to have something like that.

➤ Mrs. Smith – Parks

- Thanked Mrs. Shaw for her hard work of sprucing up the Welcome sign area with Mums.

➤ Mr. Fontes – Water & Sewer

- Asked the Council to consider using excess Water & Sewer funds to pay down the Loan on the Waste Water Treatment Plant to lower Interests rates & look better for more Grants.
 - Lengthy Discussion
 - Council Consensus was to add it to the next Agenda for further discussion.
- Asked the Council to consider using excess General Fund monies to purchase land for a new Town Hall/Government Complex by Ewing Park.
 - Lengthy Discussion
 - Council Consensus was to have Mr. Branham call to see if a better price than \$350,000 was possible.

➤ Mrs. Kirk – Treasurer – Nothing

➤ Mrs. Shaw – Streets

- Mr. Bass asked about all the cutting through of Semi Trucks on Dixie Avenue. Mrs. Smith said she would look into a "No Truck Route" sign.

➤ Mr. Mellecker – Zoning – Nothing

➤ Mr. Branham – Attorney – Nothing

➤ Mrs. Knagge – Clerk

- Thanked the Council for allowing her to attend the Clerk's Conference.
Stated she was able to represent the Town by offering the Invocation, and helping the other Graduating Clerk's with a collection of about 400 pairs of shoes to donate to a local charity. She also stated she will let the Council know as soon as her official graduation of "Certified Municipal Clerk" is approved.
- Stated the Employee Christmas Party is coming up.
- Date of December 18th was recommended.
- Council Consensus was to add it to next meeting's Agenda.

➤ **Mr. Williams – Town Manager**

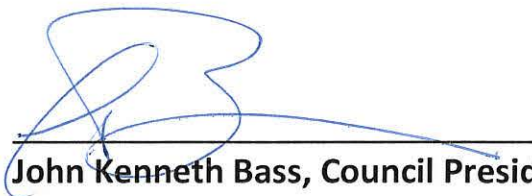
- Spoke with Mr. Estep & his office staff. They are looking for answer to more of our questions on if the EOC was activated.
- Found out that if the area was declared a State of Emergency the Town would get 75% of monies spent back. If there isn't a declaration the Town is responsible for 100%.

➤ **Mr. Bass – Council President & Fire**

- Stated that if the Town doesn't get serious about Annexation we will be left behind from the growth and will not have the funds to support the new Government Complex that Mr. Fontes recommended.
- Inquired about timeframes for Annexation from Mr. Branham.
 - Mr. Branham said Voluntary Annexation would take 3-4 weeks and Involuntary would take 3-4 months or more.
