Town Council Meeting Minutes

August 3, 2015

- II. **Pledge of Allegiance to Flag & Invocation** – Mayor Rau
- III. **Visitors Welcomed & Reminded Meeting Minutes are Being Recorded** – Mayor Rau
- IV. **Persons Wishing to Address Council – 3 Minute Limit** – Mayor Rau
- V. **Minutes**
 - Motion to Approve the Minutes by Mr. Fontes and 2nd by Mr. Mellecker.
 - Discussion: Mr. Fontes stated the items on the first page needed to be changed to Mayor Rau not Mr. Bass.
 - Motion Carried.
- VI. **Treasurer's Report**
 - Motion to Approve the Treasurer's Report by Mrs. Shaw and 2nd by Mrs. Smith.
 - Motion Carried.

VII. Business

- Resolution 2015-R13 – FRDAP Phase 5 Ewing Park
 - Read by Title by Mr. Branham.
 - Motion to Approve Resolution 2015-R13 by Mrs. Smith and 2nd by Mr. Fontes.
 - Discussion:
 - Mrs. Smith stated that the Recreation Committee had met and recommended that the Council move forward with this Grant.
 - Mr. Branham stated that there was a scrivener’s error in the last whereas paragraph that needed to change to fiscal year 2015-2016.
 - Motion Carried.
 - Mr. Williams stated to move forward with the Grant the Council needed to update the Capitol Improvement Plan. The only change in it needed to be the amount of \$50,000 in the column 2016-2017.
 - Motion to accept the Capital Improvement plan with recommended changes by Mr. Fontes and 2nd by Mr. Mellecker.
 - Discussion: Mr. Fontes asked why the amounts were so high and Mr. Williams reminded the Council that these are just goals not actual amounts that will be spent.
 - Motion Carried.
- FDOT Traffic Light Agreement – Review & Approval – Tabled
- Clerk’s Salary
 - The Clerk passed a list of her responsibilities and what she thinks the Salary should be increased to.
 - Mr. Fontes recommended tabling this matter until Mr. Bass can return from his illness.
 - Mrs. Smith stated her concerns about if the current Clerk were to leave could her position be replaced by someone willing to do as much for the Town to warrant the increase in pay. Mr. Fontes stated that if that time arouse than what goes up can always come back down.
 - Council consensus was to table the matter until Mr. Bass can return.

 - Mr. Mellecker stated that there has been a problem with attendance & communication of absences with the Board. He stated that at the next meeting he planned to find out if anyone wanted off the Board or if the Board needed to change the meeting time from 6:00 to 7:00, so that people can arrive on time.
 - Mr. Fontes stated that being this is a paid position, and that the P & Z Board should be held to the same standards of attendance as the Council.
 - Mr. Mellecker will report back at the next Council Meeting his findings.
