 - Mr. Branham Read by Title.

 - Closed Public Hearing & Reopened Regular Meeting at 7:06 PM
 - Motion to approve first reading of Ordinance 2017-006 by Mr. Mellecker and 2nd by Mrs. Smith.
 - Discussion:
 - Mr. Fontes stated the wording isn't correct. Stated it should state "Industrial over 1 million gallons will have a contract approved by Resolution by the Council"
 - Mr. Branham stated that this captures that.
 - Mr. Fontes stated he worried it would capture a trigger for trouble.
 - Mr. Branham stated that it captures it no matter what.
 - Mr. Fontes stated the 3-6 months part should be removed.
 - Mr. Branham stated the change would state "Industry who use more than 1 million gallons per month will have a contract approved by the Council."
 - Motion to <u>approve first reading of Ordinance 2017-O06 with stated changes</u> by <u>Mr. Mellecker</u> and 2nd by <u>Mrs. Smith</u>.

 - Mr. Fontes stated that Mr. Haugh is a great family man who already does a lot for Callahan and he will be an excellent addition for the Town.

- Fire Department Roof Bids Tabled due to lack of Bids.
- Park Pavilion Bids Tabled
 - Only received 1 Bid that was \$40,000 and due to amount of Grants it's too high.
 - Mr. Williams stated that this will now be open to other people in hopes of receiving a reasonable rate.

- Repair #1 Lift Station (Emergency)
 - Mr. Fontes stated that this is a major repair that cant wait. At this time Mr. Williams has only received one bid and should receive a second in the morning.
 - Mr. Fontes asked the Council to approve Mr. Williams to spend up to \$19,200 which was the Bid received from PBM Contractors of Jacksonville.
 - Motion to approve Mr. Williams spending up to \$19,200 to repair #1 Lift Station by Mr. Fontes and 2nd by Mrs. Smith.

 - Mrs. Smith asked where this lift station is located. Mr. Fontes stated behind the old SuperTest.
