    - Mrs. Shaw asked about Spot Zoning.
    - Mrs. Smith stated she thought we have a Conditional Use problem, and maybe we shouldn't allow it.
    - Mr. Williams stated if the Law Office sold the Conditional Use would not carry over to the purchaser.
    - o Mr. Mellecker stated there isn't a lot of traffic with a law office.

- Delinquent Water & Sewer Accounts
  - Mayor stated the Water & Sewer accounts need to be cleaned up.
    - Write off \$8,760.14 of uncollectable debts
  - Motion to write off \$8,760.14 of uncollectable debts from the Water & Sewer Account by Mrs. Graham and 2<sup>nd</sup> by Mr. Mellecker.

- Distribution of Water & Sewer Meter and Advanced Funds
  - Mayor stated the Meter & Advanced fund has \$9,094.79 that is not attached to any accounts and need to be moved to the Water & Sewer Fund
  - Motion to move \$9,094.79 to the Water & Sewer Fund by Mrs. Graham and 2<sup>nd</sup> by Mrs. Shaw.
  - Discussion: None
  - Motion Carried
- Application for 'Florida Job Growth Fund' for Infrastructure
  - Mayor stated we are in the running for a 5 million dollar grant for infrastructure for the Crawford Diamond Industrial Park. If approved by Mayor Scott those funds plus \$4.5 million from FPL would handle the cost of pipelines for the Town to handle the Water & Sewer for the Industrial Park. This would be beneficial for anyone along that corridor who has been wanting to tap into town water & sewer. Asking that the Council grant him permission to sign paperwork for the Grant, and work on moving forward with it.
  - Motion to give Mayor Fontes authority to sign documents for the grant by Mrs.
    Smith and 2<sup>nd</sup> by Mrs. Shaw.
    - Discussion

- Mrs. Graham asked if the piping is strictly for FPL Customers. Mayor stated they would be for anyone wanting to tap in.
- Mr. Mellecker asked what property we would be using. Mayor stated all DOT right of way.
- Mrs. Smith asked when we would hear of the acceptance. Fontes said before Mayor Scott leaves office, so soon.
- Mrs. Graham asked Mr. Branham asked if there was anything we should be concerned with, and he stated only about 500 jobs, but that is in a 15 years.
- Laura Dibella stated the next step would be the Mayor signing a contract with the DEO, and that the job requirements is 800 in 15 years.
