 - Mayor stated it shouldn't be changed because if it's too detailed then there can be more issues.
 - Council Consensus to leave the same.
 - Mr. Williams Stated person wishing to put in an RV Park has asked: "Would the Council consider excepting fencing over the hardwood buffer?"
 - Mrs. Smith said, "No, because we need our town to look nice and trees make that happen. Looking at a Fence is not pretty. In fact, it may need to be 20 feet apart instead of 15 feet."
 - Mrs. Shaw stated she agreed to the 20 feet.
 - Mr. Mellecker stated this is a City, and cities don't have to have trees, and if we start getting too detailed we are asking for trouble.
 - Mr. Fontes stated he felt this all could be handled in the Commercial Landscape Plan.
